Fairley HS, Hillcrest HS, Kirby MS, and Wooddale MS operate under the approval of the Tennessee Department of Education (TDOE) and are part of the Achievement School District. During the fiscal year ended June 30, 2019, Bluff City HS was opened under the approval of the TDOE. Fairley HS, Hillcrest HS, Kirby MS, Wooddale MS, and Bluff City HS receive per-pupil funding to help support operations. (See Schedule O)
